  - Match Control, Foul Selection vs Foul Recognition
  - Player Management
  - Positioning and Movement (Fitness/workrate)

### **Denying Obvious Goal Scoring Opportunity (DOGSO)**

- Defined: an egregious attempt to prevent opponents from scoring.
- 4 Considerations which MUST BE PRESENT:
  - <u>DISTANCE</u> between the offense and the goal (the closer to goal the more likely it is obvious goal scoring opportunity)
  - <u>DIRECTION</u> general direction of play (moving toward the goal at the time the foul was committed)
  - <u>CONTROL</u> the likelihood of keeping or gaining control of the ball (the attacker must have been close enough to the ball at the time of the foul to have continued playing the ball)
  - <u>DEFENDERS</u> the location and number of defenders (not more than one defender between the foul and the goal, not counting the defender who committed the foul)

IF ANY ELEMENT IS MISSING, THE PLAYER CANNOT BE DISQUALIFIED FOR DOGSO.

### **Denying Obvious Goal Scoring Opportunity (DOGSO)**

#### **DOGSO: DISTANCE - DIRECTION - CONTROL - DEFENDERS**

When considering the criteria above: ask yourself the following:

- Where does the offense occur on the field?
- Did the foul occur inside or outside the penalty area?
- What is the distance between the offense and the goal?
- What is the direction of play?
- Does the player have control of the ball?
- Can the player gain control of the ball?
- How many defenders are involved in the situation?
- Where are the defenders located?
- Does the offense lead to a direct free kick or indirect free kick?
- If no offense were to occur, would the player have an obvious opportunity to score a goal?
- Does the player deliberately handle the ball to deny the opposing goal?
- Was the offender attempting to play the ball?

#### **Stopping a Promising Attack (SPA)**

**SPA: SPEED, SPACE, OPTIONS** 

When considering the criteria above: ask yourself the following:

- What is the distance between the offense and the goal?
- Does the player have control of the ball?
- Can the player gain control of the ball?
- What is the direction of play?
- How many defenders are involved in the situation?
- Where are the defenders located?
- How many attackers are involved in the situation?
- Where are the attackers located?
- How many options to pass the ball does the player have when fouled?
- Does the challenge stop a promising attack?
- How much open space is there for the attacker to move?
