- C-2 Persistent infringement
- C-3 Dissent
- C-4 Incidental use of vulgar or profane language
- C-5 Use of video/audio equipment to assist in coaching
- C-6 Unsporting Conduct
- C-7 Use of any tobacco products

## Disqualifications

- D-1 Violent conduct (or spitting at)
- D-2 Taunting
- D-3 Subsequent Caution
- D-4 Serious Foul Play
- D-5 Spitting
- D-6 Using insulting, offensive or abusive language or gesture
- D-7 Leaving team area to enter field during a fight or altercation
